The kitten is purchased as a breeder, he is guaranteed to produce viable semen. If the kitten has not been able to produce kittens till the age of 3 years and has been bred with more than one proven producer in an appropriate manner conducive to breeding cats, the Breeder will replace him with a kitten of equal value from her cattery, upon veterinary verification of congenital sterility. (fertility guarantee applies to males only)

Kitten's purchase price (including deposit):

Deposit: 50%-of purchase price:

Shipping price is not included in the kitten's price. Kitten only leaves the Breeder when full purchase price + shipping price was paid by the Buyer. The Buyer must pay the deposit within 10 days to the Breeder's bank account after the Contract was signed by the Breeder. Buyer must take or receive the kitten home till (date).

If he / she fails to do so the Contract is considered cancelled by the Buyer. The Breeder must do everything to work out the most suitable shipping circumstances for the Buyer.

The kitten/cat will not be mistreated, and will have fresh food, water and a clean litter box at all times. The kitten/cat will receive frequent and kind human attention. The kitten/cat will be provided with scratching post or/and cardboard scratchboard, as well as with plenty of toys.

The kitten/cat will receive yearly veterinary examination to include any care needed to maintain the ongoing good health of this animal.

The kitten/cat will not be denied veterinary care at any time.

The kitten/cat will not be allowed outside except on a leash (under close supervision), or in a completely enclosed run. The kitten/cat will not be caged, or kept in an unsuitable room, basement or garage.

The kitten/cat will not be declawed.

The Buyer will not, under any circumstances, give, sell, or lease the kitten/cat to any animal shelter, research facility, laboratory, pet store, or other commercial or non-commercial enterprise.

In the event that the Buyer can no longer keep the kitten/cat, the Breeder will be contacted immediately as a first option to assist in the rehoming of the animal.

If this kitten/cat is found to be neglected or mistreated, the Buyer will surrender the kitten/cat to the Breeder or the Breeder's representative unconditionally.

Health guarantee

1. The Breeder guarantees the kitten/cat to be healthy at the time of sale (to the best of our knowledge). The kitten will be chipped, vaccinated against feline panleukopenia/cat flu, rabies, parents tested negativ for FeLV/FIV/Pk Deficiency.
2. This guarantee is valid for 7 days from the date of purchase. During this period of time, the kitten/cat should not be exposed to any animals (doing so will void this health guarantee).

The Breeder recommends the Buyer to take the kitten/cat to their own veterinarian (at Buyer's expense) within the 7 days for their own satisfaction and protection. If the vet feels that the animal is ill and that the illness was present prior to sale, the Breeder should be contacted at once, before any major treatment is begun (except in an emergency situation).

If the kitten/cat should die during the legal warranty time (six months) from a problem present prior to sale, the Breeder will either replace the animal from his breed with one of an equal quality (if available). If not available, Buyer can choose an other kitten from Breeder with pro rata payment.

3. The Breeder guarantees against the death of the kitten/cat due to innate genetic defects for legal warranty time (tumors, FeLV, FIV, and FIP are not innate genetic and are specifically excluded). In the unlikely event of death of this kitten/cat due to innate abnormalities (proof is to be provided to the Breeder in the form of a detailed autopsy report and a letter written by a licensed veterinarian stating the exact cause of death, and including the description of the kitten/cat's date of birth, name, sex, color and pattern, chip-number), the Breeder will replace kitten/cat from his breed with one of the equal quality (if available). If not available, Buyer can choose an other kitten from Breeder with pro rata payment.
4. Health guarantee will not be honored if ownership changes.
